TO: Robert G. Hamod, Special Agent, Federal Bureau of Investigation, and any other Authorized Officer of the United States:

Affidavit(s) having been made before me by Robert G. Hamod, who has reason to believe that on the premises known as the account(s) associated with the username "fiddlestix1" or Harold Anthony "Tony" Trout, or the monitoring of "JKernell on COUNTY ADM01" on the "Remote Spy" service, which is in the possession of CyberSpy Software, LLC, headquartered at 1512 E. Jefferson Street, Orlando, FL 32801, there is now concealed certain property, namely (1) the name, address, records of session times and durations, length of service (including start date), types of services used, IP address used to access the service, and means and source of payment for such service (including any credit card or bank account number); (2) logs or other records of accesses to remotespyspy.com; (3) all files stored by or on behalf of the user; (4) all communications or other data that is accessible to the User and was collected from any computer with Remote Spy software installed; (5) contracts or other agreements between the user and Remote Spy; and (6) any other records, information, or communications in the possession of Remote Spy that pertain to the user; I am satisfied that the affidavit(s) and any recorded testimony establish probable cause to believe that the person or property so described is now concealed on the person or premises above-described and establish grounds for the issuance of this warrant.

**YOU ARE HEREBY COMMANDED** to search on or before June 27, 2008, for the person or property specified, serving this warrant and making the search **in the daytime - 6:00 a.m. to 10:00 p.m. / ~~at any time in the day or night as I find reasonable cause has been established~~**, and if the person or property be found there to seize same, leaving a copy of this warrant and receipt for the person or property taken, and prepare a written inventory of the person or property seized and promptly return this warrant to William M. Catoe, United States Magistrate Judge, as required by law.




