**GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:**

On or about April 30, 2001, at approximately 7:30 p.m., a witness (hereafter W1) saw a young Caucasian female, known to W1 as Chandra Levy, at the Washington Sports Club, located at 1211 Connecticut Avenue, N.W., Washington, D.C. According to W1, Ms. Levy was, at that time and place, canceling her membership to the gym in light of her imminent plans to return to California. W1 described Ms. Levy as physically healthy and emotionally upbeat during their conversation. W1 saw news coverage of Chandra Levy's disappearance along with her photograph and identified Levy as the same person who cancelled her gym membership on April 30.

On May 6, 2001, Robert Levy, father of Chandra Levy, contacted the Metropolitan Police Department and reported his daughter missing, after he made numerous attempts to contact his daughter with no response.

Thereafter, on Thursday, May 10, 2001, members of the Metropolitan Police Department executed a search warrant upon Chandra Levy's Dupont Circle apartment located at 1260 21<sup>st</sup> Street, N.W., #315, Washington, D.C., and recovered a number of items, including Ms. Levy's laptop computer. Special Agent Jane Dembrowski, with the Federal Bureau of Investigation, traced the internet history contained within the computer's hard-drive. Agent Dembrowski ascertained that sometime during the morning hours of May 1, 2001, an individual logged on Ms. Levy's computer and queried websites relating to Rock Creek Park (referred to also as "the Park") and conducted a "Mapquest" search for 3545 Williamsburg Lane, Northwest, Washington, D.C., which is the location of the Klinge Mansion in the Park. The Klinge Mansion is situated near the series of connected trails that includes the Western Ridge Trail. According to Agent Dembrowski, the last verifiable activity on the computer was time-stamped at 12:25 p.m. on May 1, 2001. From that point forward, no outgoing activity could be detected on Ms. Levy's computer, her home telephone line, or her cellular telephone, which was also recovered in her apartment. Upon information and belief, Ms. Levy left her apartment, destined for the Western Ridge Trail in the Park, sometime during the early afternoon hours of May 1, 2001, never to be heard from again.

On or about May 1, 2001, at approximately 2:00 p.m., a witness (hereafter W2), who is a young Caucasian female, was walking alone on the Western Ridge Trail in the Park. W2 believes that she entered the Park at Porter Street, N.W., in the vicinity of Pierce Mill. As W2 reached an isolated and wooded part of the trail, slightly east of the Klinge Mansion, she noticed a lone Hispanic male, walking in the woods, parallel to W2's route. According to W2, the Hispanic male just appeared, suddenly, to her right. W2, feeling uncomfortable, slowed down, hoping that the Hispanic male would simply pass by her. As W2 watched, the Hispanic male walked ahead through the woods, joined another trail, and disappeared around the corner. W2, more at ease but still cautious, decided to take a detour, leaving the trail the Hispanic male had taken. W2 veered off and began climbing a steep incline, walking deeper into the woods. Within a minute, W2 again sensed someone in the woods. W2 turned and saw that the Hispanic male had somehow circled around and was now directly behind her on the hillside in the woods. As W2 watched, the Hispanic male came toward her and closed the distance to within ten feet. At that point, W2 panicked. W2 ran off the path and down the hill, jumping over logs and through the woods, until she reached a road outside of the Park. Once she felt safe, W2 turned around to locate the Hispanic male, who was no longer in sight.

That night, W2 told another witness (hereafter W3) about what happened in the Park. Neither W2 nor W3 thought to report the incident to the police. Shortly thereafter, W2 left the country and did not think anything more about the events in question until May 2002. At that time, W2 was out of the country, but saw a newspaper article that contained a photograph of Ingmar Guandique. Upon seeing the photograph, W2 immediately thought that the photograph of Guandique looked like the man who followed her in the Park a year earlier. Then, in May 2003, while back in the United States, W2 saw a television broadcast about the Levy case that included a picture of Guandique and that also asked for anyone with information to contact the police. Once again, upon seeing Guandique's picture, W2 immediately thought that he looked just like the man who followed her in the Park back in 2001. To the best of her ability, W2 now believes the date of the incident in the Park occurred hours before a dinner with W3. By referring to its day planner from 2001, W3 believes the day in question to be May 1, 2001, which would place defendant Ingmar Guandique in the Park on the Western Ridge Trail, shortly before Chandra Levy disappeared.

Another witness (hereafter W4), who knows Ingmar Guandique, was interviewed and said that W4 saw Guandique around the time that Levy disappeared in 2001 with a fat lip and scratches on the side of his face and neck. Guandique told W4 that he received the injuries to his face and neck from his girlfriend during an argument.

Another witness (hereafter W5), who was the girlfriend of Ingmar Guandique at the time of Chandra Levy's disappearance, was located and interviewed. W5 said that there were occasions during the relationship with Guandique where the two argued and also occasions where Guandique hit her, grabbed her by the throat, and bit her on the breast. W5 said that at no time during any of the arguments or fights did W5 ever strike Guandique or cause any injuries to his face or neck.

Two weeks after the events described by W2 and the disappearance of Chandra Levy, another female jogger was attacked in the Park. On or about May 14, 2001, at approximately 6:45 p.m., a witness (hereafter W6), who is a young Caucasian female, was jogging alone on the Western Ridge Trail in the Park. W6 remembers that, like W2, she entered the Park at Porter Street, NW, in the vicinity of Pierce Mill. Unlike W2, however, W6 was wearing a walkman with headphones and listening to music. As W6 reached the parking lot in Grove 2, she noticed and made a mental note of a lone Hispanic male, who was sitting on a curb, watching her as she jogged by. W6 continued jogging along the trail, entering an isolated and wooded area, abutting a ravine, and slightly northwest of the Klinge Mansion. For reasons that she cannot explain, W6 looked behind her and saw what she originally thought was another jogger, a male, following her at some distance. Feeling uncomfortable, W6 began to periodically check behind her as she ran. She noticed that the male jogger appeared to be running "splits," i.e., he was both speeding up behind her and then slowing down as W6 slowed her pace. As W6 ran up an incline, she

slowed even more, hoping the male jogger would simply pass by. Suddenly, and without warning, W6 was tackled from behind, and grabbed, in a choke hold, around her neck. As W6 struggled, she turned and recognized that her attacker, the male jogger, was the lone Hispanic male from the parking lot at Grove 2, and that he had a knife. At that point, W6 started screaming for help. Still holding the knife to her throat, the Hispanic male told W6 to be quiet and pushed her to the ground, knocking off her Walkman in the process. W6 realized that no one could hear her screams, and she tried to stay calm. Using a technique she learned in self-defense class, W6 reached up and dug her fingernails into the Hispanic male's soft pallet. At that point, her attacker bit her finger, and then, ran off.

W6 reported the attack to the United States Park Police, who returned to the scene of the attack and recovered her Walkman where it had fallen on the trail. On September 17, 2001, W6 was shown a photo array consisting of nine, similar looking, Hispanic males. W6 selected the photograph of Ingmar Guandique, PDID 527-533, as the person who followed her into the woods and attacked her at knifepoint. W6 later said of this attack, "I do not doubt for a minute that he purposefully stalked me as a hunter tracks his prey. I know in my gut, that given the chance, he would not hesitate to repeat his crime on some other woman and it scares me to think what would happen if she was not prepared with some sort of self defense."

Two months to the day after Chandra Levy's disappearance, and less than six weeks after the attack upon W6, Ingmar Guandique struck again. On July 1, 2001, at approximately 7:30 p.m., a witness (hereafter W7) was jogging on the Western Ridge Trail in the Park. Like W2 and W6, W7 entered the Park in the vicinity of Pierce Mill and was wearing a Walkman with headphones. As W7 reached the picnic area in Grove 6, she made a mental note of a lone Hispanic male, who was sitting on a park bench, watching her as she jogged by. W7 continued jogging along the trail, entering an isolated and wooded area of the Park, which abutted a ravine. Suddenly, and without warning, W7 was tackled from behind and grabbed, in a choke hold, around her neck. As W7 struggled, she recognized her attacker as the lone Hispanic male from the Grove 6 picnic area and saw that he had a knife. As W7 tried to scream, the Hispanic male covered her mouth with his hand and held the knife to her throat, telling her to be quiet. At that point, despite a significant size differential, the Hispanic male threw W7 to the ground and down into the ravine, where he lay next to her with the knife still at her neck. Realizing that no one could hear her screams, W7 stopped struggling to regain her wits. In return, Guandique relaxed his grip. W7 then renewed her struggle and broke free, running up the incline to Beach Drive, where she was able to flag down assistance.

W7 reported the attack to the United States Park Police. Approximately forty five minutes later, Ingmar Guandique was stopped at the corner of Joyce Road and 16<sup>th</sup> Streets, Northwest, with wet leaves and other debris on his legs and shoes. In a subsequent "show-up" identification procedure, W7 positively identified Ingmar Guandique, PDID 527-533, as the man who attacked her. Her Walkman, which W7 had been wearing at the time of her attack, was recovered some five to six feet from the road at the top of the ravine. W7 later described her assailant as "extremely strong, and with his hand cutting off my air and the knife at my throat, I didn't feel I could struggle for very long....He was a bold and practiced attacker, not deterred by the physical size and strength of his target....He waited until he thought I was fatigued from jogging up a hill, and purposefully selected a secluded spot right next to a deep ravine. I fear for other women who may appear to be more vulnerable than I did."

At the time of his arrest on July 1, 2001, Guandique was questioned, through an interpreter, by members of the United States Park Police and initially denied any involvement in the attacks upon W6 and W7. When confronted with the fact that he had been stopped in the area and positively identified by W7, Guandique latched onto the idea, as suggested by one of the officers, that his contact with W7 was accidental. At that point Guandique claimed that, while he was jogging in the Park, he stopped to massage a muscle cramp in his leg. At that time, so he claimed, a woman, W7, ran into him, causing them to become entangled and fall from the jogging trail into a ravine. According to Guandique, when he attempted to help W7, she began to scream, apparently thinking that his bracelet was a knife.

With respect to W6, and again after initial denials, Guandique gave an equally far-fetched account. According to Guandique, about two months before the attack upon W7, he was jogging behind a woman, who was running on a horse trail south of the police station. Guandique claimed that when the woman, W6, looked back over her shoulder, she accidentally stumbled and fell down. When he came to her aid, she started screaming, which caused him to run away. In both incidents, Guandique denied possessing a knife.

On July 19, 2001, Guandique was interviewed by the Court Services and Offender Supervision Agency, in preparation for sentencing in an unrelated burglary case. At that time, and contrary to his earlier denials, Guandique now admitted assaulting or attempting to assault a number of women in the park, but contended that the attacks were actually attempted robberies; even though nothing of value had been taken, nor was any attempt made to take anything from the victims. Guandique had this to say: "I admit that I assaulted the victim, but I did not have a knife on me. I pushed her into the ravine, so no one would see the robbery. I was coming from Silver Spring, Maryland on foot. I have walked from Silver Spring on several occasions. I tried to rob another lady near Rock Creek Park in May, about 15 days after the first arrest. But she was too close to the street where there were cars passing by, so I was unsuccessful. I have tried to commit robbery 3 times in the U.S. While in El Salvador, about five months prior to immigrating to the U.S. (around October/November 2000), I also tried to rob a 17 - 18 year old guy. I tried to take his cap, but I ran when someone came to his aid. During the most recent incident, I tried to take what appeared to be a bracelet and her walkman, but I was unsuccessful. She was coming one direction, and I from the other. I noticed that no one was nearby, so when she got close to me, I pushed her into that ravine. I feel bad about what I did. I am repentant for what I did. I do not know if she was hurt. When I'm about to commit an offense, I tell myself to go ahead and do it, but afterwards, I feel bad about it. I feel good when I see someone alone and carrying something of value on their person because it makes it easy for me to take it from them. Then it crosses my mind after doing it so many times I will eventually get caught. Sometimes, I cannot control myself when I see someone alone in a secluded area with something of value..." Upon information and belief, none of the victims were carrying wallets, purses, or other obvious items of value. To the extent any of the victims were wearing Walkman radios or rings, Guandique never, by word or gesture, demonstrated any interest in taking these items. Indeed, nothing was taken from any of the known victims.

On September 28, 2001, Guandique pleaded guilty to the attacks on W6 and W7. Specifically, he pleaded guilty to two counts of assault with intent to rob and was sentenced on February 8, 2002, to 10 years' confinement on each count, with the sentences running concurrent with one another.

During the early morning hours of May 22, 2002, more than a year after the disappearance of Chandra Levy, a witness (hereafter W8) was walking his dog along a foot path, which is part of the Western Ridge Trail of the Park. Near Grove 17, W8's dog stumbled across what appeared to be a skull, partially buried in the leaves and underbrush, in a ravine off to the left of the trail. W8 marked the site and went for assistance. Sergeant Bosak of the United States Park Police returned to the scene with W8 and verified that the skull was, in fact, human. Through dental records, the human skull recovered from the ravine was subsequently identified as Chandra Levy's remains.

In the days that followed, an extensive search was conducted of the area. The scene itself is in an isolated and heavily wooded area of the Park, which drops sharply from a narrow trail, into a ravine. The trail is part of a network of trails including the Western Ridge Trail, which leads from Pierce Mill, along Rock Creek, to the Nature Center, which is a short distance to the north. Items of evidence, including a broken pair of sunglasses, a Walkman radio, and headphones were strewn from the trail, down a steep hill, and deep into the woods. The majority of items, including woman's running clothes and a number of bones, subsequently identified as those of Chandra Levy, were discovered in one location, about 180 feet from the trail. The laces of the running shoes were untied. A sports bra, t-shirt and tights, all believed to be Ms. Levy's, were turned inside out. The tights were found knotted into restraints in each leg portion.

Chandra Levy's partial remains were collected and examined by both the Office of the Chief Medical Examiner for the District of Columbia and Doctor David Hunt, a forensic anthropologist with the Smithsonian Institute. To the extent he was able, given that a complete set of bones was not recovered, David Hunt concluded the following with respect to the bones; (1) they were in a condition consistent with being in the woods one year; (2) they had no evidence of nicks; and (3) they had evidence of animal activity. The Medical Examiner, Dr. Pierre-Louis, reviewed the autopsy and although unable to determine the cause of death, Dr. Pierre-Louis ruled that, given the remains and the other evidence from the crime scene, the manner of death was Homicide.

The attacks upon W2, W6, W7, and Chandra Levy were all in close proximity within the Park. The attack upon W2 was within approximately one (1) mile of the attack upon W6, which is within approximately one-half (1/2) mile of the Chandra Levy scene, which is within approximately one-and-one-quarter (1 1/4) miles of Guandique's home, and very near where Guandique was arrested after the attack upon W7, which is within approximately one (1) mile of the attack upon W7. All said, these four (4) attacks, as well as Guandique's home address and arrest location, are within an area that is approximately three miles by one mile. Given Chandra Levy's internet searches and her choice of clothing, including a sports bra, running shoes, and insoles, Ms. Levy clearly was in the Park voluntarily and by choice. In all likelihood, Ms. Levy passed through Pierce Mill, in the vicinity of the Klinge Mansion, to access the Western Ridge Trail. At some point in the afternoon, she traveled along a narrow footpath, just north of Grove 17, in a remote and heavily wooded area that does not receive a great deal of foot traffic, especially during weekdays. Like Guandique's other attacks, the attack against Ms. Levy was one of opportunity and committed by a stranger. The scene shows a significant struggle with articles of clothing, including a broken pair of sunglasses, strewn from the path, down a steep hill, towards the bottom of a ravine. At some point, in the vicinity where her clothing was recovered, Ms. Levy was apparently subdued. Given that her shoes were unlaced, her clothing turned inside out, and her tights knotted into restraints, it appears that Guandique wanted Ms. Levy naked and incapacitated. The evidence clearly demonstrates that this crime was not a simple robbery.

Another witness (hereafter W9) was interviewed in late 2008 and said that in 2003, W9 communicated with Ingmar Guandique many times through letters. W9 said that during the course of these communications, Guandique wrote that he spent time in a park in D.C. and that he was responsible for the murder of a young woman. W9 became nervous of Guandique given that he had admitted to killing a young woman, and later, during a recorded telephone conversation with Guandique, questioned him about the murder. During this recorded conversation Guandique acknowledged that he had told W9 about the "girl who's dead."

In November 2008, a witness (hereafter W10) was interviewed in connection with the investigation. W10 stated that it has known Guandique for many years. During the course of several conversations between W10 and Guandique, Guandique boasted to W10 that he was a member of MS-13 and that he committed many robberies. Guandique boasted further that he was known as "Chuckie," because he had a reputation for killing and chopping up people. Guandique also confided to W10 his thoughts about women. Specifically, Guandique told W10 that he committed many crimes against women, including rapes. Guandique stated that he and his gang members grabbed girls that they liked and wanted, as follows: Guandique said that he would hide on a dirt path and wait for the girl to walk by. He would then lasso the girl around the neck and tie her hands and feet together behind her back to prevent her from scratching or kicking him. He claimed that he would tie the girl up with a rope, but that, if he did not have a rope, he would improvise and use whatever was available. After the girl was tied up, he would rape her. Guandique admitted that he did not always know whether his victims were still alive at the end of the attack, but that it did not matter, because they would be eaten by the animals, like coyotes and vultures. During the course of one of these conversations, Guandique told W10 that he and two other males were in a park when they saw a female jogging on a path. Guandique said that the female looked Italian with thick, dark hair. Guandique said that one of the men jumped in front of her, and then he (Guandique) grabbed the woman from behind, around her neck, with his arm, and that he dragged the woman from the path into a secluded area. Once into the woods, the woman was knocked unconscious and they tied her feet together. Guandique confessed further that they put something in the woman's mouth so that she could not scream while they raped her.



Guandique told W10 that the woman began to regain consciousness during the rape, so he cut her throat and stabbed her.

In September 2008, your affiant along with other members of the Metropolitan Police Department traveled to the Victorville Correctional Institute in Adelanto, California, to obtain and execute a search warrant on the jail cell of Ingmar Guandique. Your affiant observed many gang-related tattoos on Guandique's body, including the words "Mara Slavatrucha" on his neck, a picture of a devil on the top of his head, an image of the character "Chuckie" holding a knife on his back, and a naked female on his chest, as well as the letters "M" and "S." Additionally, a photograph of Chandra Levy, appearing to have been taken from a magazine, was recovered from Guandique's cell.

In February 2009, a witness was interviewed (hereafter W11), who stated that over the course of several weeks, Ingmar Guandique told W11 that he was involved in the murder of Chandra Levy and that he had been under investigation since August of 2002. Guandique described the crime as follows: he admitted that he and two teenage males were sitting on a bench in a "big park" that stretches from D.C., through Maryland, and Virginia, smoking marijuana laced with cocaine, when he saw Levy jogging in an area where people walk their dogs. Guandique told W11 that when he saw Levy, she had curly hair, and he thought she "looked good." He told the other two males that he was going to "get her." According to Guandique, the three then followed Levy along a track where the ladies run. Guandique stated that they grabbed her and took her into the bushes. Guandique said that they "had her down," and the "bitch" started screaming and fighting back. It was then, according to Guandique, that he grabbed her by the neck and choked her to death, because she was screaming and there were people jogging in the area. Guandique told W11 that after they murdered Levy, they buried her under some leaves. Guandique explained further that during the course of the murder, Levy scratched him on the face. Guandique told W11 that after the murder, he told his family that if the law should question them about the scratches on his face, they should say it was because of a fight with his girlfriend "Iris." Guandique also admitted that he attempted to rape two other women in the park with a knife, who got away, but that he pled guilty to crimes of burglary, robbery and assault.

W11 was present when Ingmar Guandique heard a recent news report on the radio, broadcasting that he would be arrested soon for the Chandra Levy murder. W11 said that Guandique became very anxious and said something to the effect of, "fuck, it's over. They got me now. What am I gonna do." Guandique then exclaimed that he was "not going out alone" and explained what he meant. Guandique told W11 that when the detectives came to arrest him, he was going to escape by starting a fire with a battery and tissue to cause a distraction; that he would then use a handcuff key he had fashioned from toenail clippers and a piece of metal, to escape the handcuffs, and that he was going to kill the detectives with prison "shanks" made out of blades and toothbrush handles. W11 said that Guandique told him that he was going to wrap the items tightly in plastic and hide them in his rectum until they were needed.

On February 26, 2009, prison officials at Victorville USP, removed Ingmar Guandique from his cell, searched the cell, and secured all property from within it. On that same day, a warrant was obtained to search the property removed from Ingmar Guandique's cell. Located within this property were the implements by which Ingmar Guandique could carry out the threat against Law Enforcement Officers, including a "AA" battery with several pieces of tissue, a broken off piece of a toenail clipper along with a small, sharp piece of metal, several loose razor blades, a device with two razor blades that were secured to a small piece of plastic, and several pieces of plastic.

Indeed, as early as 2002, Guandique had discussed the murder of Chandra Levy with a witness, W12. Although inconsistent in some respects with accounts he gave to other witnesses, Guandique admitted to W12 that he had killed Chandra Levy, and claimed others were also involved with him in the homicide. Additionally, after discussing the Levy murder with W12, Guandique and W12 communicated in a series of written letters. In one such letter, Guandique wrote to W12, "what I think about what we spoke when we met, is that you are a good

friend, because not everybody keeps to himself something like what I told you.”

Based on the aforementioned facts and circumstances, your affiant submits that there is probable cause to believe that Ingmar Guandique attacked and killed Chandra Levy. It is therefore respectfully requested that a warrant be issued charging Ingmar Guandique with First Degree Felony Murder.
